The primary purpose of the Association is to Protect and Support the Allotments Sites

The Association acts on behalf of the allotment tenants, for both Foxes Piece & Hanging Hill Allotments Sites, in helping to protect, maintain & improve both of the sites. Over many years we have monitored events, which could have an impact on the integrity of the sites, and have the backing & support of the National Society for Allotment & Leisure Gardeners (NSALG), should we need it, to protect our allotments. The income MAA receives from memberships enables subscription to NSALG for every Association Member.

It is vital that the Association has high membership each year, in the event of a threat to either site, we will then be able to demonstrate that we consistently have the support of the majority of the tenants.

This will send a powerful signal to those who may doubt our resolve – there is power in numbers!!

MAA Membership also brings benefits such as the Seed Scheme and Donated Tools, please ask a Committee Member for details.

We supply a newsletter periodically to all tenants, to give them news and information plus periodic updates via email, and we also organise functions and talks, giving plot holders an opportunity to meet with other tenants and share their allotment experiences.

The Association monitors the waiting list on behalf of Marlow Town Council and ensures that plots are re-let as soon as possible after they become vacant. We also communicate with the Council regularly on matters that require their attention & attend regular meetings with them to cover Allotment issues with proposed suggestions and ideas.

The work that Committee Members and volunteers carry out is unpaid and in their spare time, for the good of the Association and we like to think that most people join the Association to help contribute to the support of the Allotments Sites, in addition to any individual benefit.
