### **BONFIRES!!!**

The Committee attended a meeting with MTC and covered the issue of bonfires onsite. Emphasising the point that it is part of the natural process of burning dried branches etc to create ash, which is then added to the soil, thereby continuing the natural cycle. The Council & the Conservation Committee agreed that fires will be allowed on both sites from 01.11.22 to 31.12.22, but only incinerators can be used, no open fires are allowed. MAA hopes for further discussions regarding future plans in the New Year.

# Track damage at Hanging Hill

As most tenants are aware vehicles are allowed onto this site, however, over recent years the quality of the track has deteriorated. This track was originally established many years ago by volunteers on the site. At the request from MAA, the Council are considering covering the cost of repairs to this track in their next budget.

# **Hanging Hill Speed Limit**

Several vehicles are disregarding the Allotment Rules for vehicles to travel at no more than 5 miles per hour. This is only a dirt track, not a standard road, cars travelling at speed will throw stones & debris into the air, which may cause damage to their vehicle, could hit nearby tenants & erode the trackway. MTC have now placed signage to remind tenants of the regulation. For the safety & consideration of others please observe this rule.

# **Woodchip Bays and Pot Swap Areas**

There will be a second woodchip bay constructed in Foxes Piece Site, to be located near the entrance by the flats. Thank you to the volunteers working on this. Please would tenants refrain from leaving broken pots & rubbish by the Pot Swap areas, this just means a volunteer must dispose of the unwanted debris.
